No protest or appeal is pending; it has become final, and has a remaining balance due of \$5,657.69.

Pursuant to RCW 49.48.086, the Clerk shall designate a Superior Court Cause Number for this Warrant and enter in the Judgment Docket the individual's name, date of filing, and the Warrant amount of FIVE THOUSAND SIX HUNDRED FIFTY SEVEN DOLLARS AND SIXTY NINE CENTS, which includes interest, penalty, statutory filing fee, and the statutory surcharge fee.

The aggregate amount of this Warrant as docketed is a lien upon the title to, and interest in all real and personal property of the Employer/individual; the same as a judgment in a civil case duly docketed in the office of such Clerk, and is sufficient to support the issuance of writs of garnishments in favor of the state, the same as a judgment whole or partially satisfied.

Delinquent wages and/or earnings bear interest at the rate of one percent per month until payment in full is received by the department. (RCW 49.48.083 and/or RCW 49.46 and WAC 296-128.)
